# WATER & SEWER APPLICATION

## IRRIGATION METER

- An approved backflow prevention device must be installed and tested on all irrigation prior to the meter installation. A copy of the test must be submitted to the DPW in accordance with the City of Howell's cross contamination program.
- The Installation of an irrigation system within the City of Howell's street right-of-way requires a Right of Way Permit.

## ALL METERS

The City of Howell Ordinance No. 1044.06 references that a pair of 22 AWG solid wires be installed from the meter flange to the outside. The line and flange must be installed before the meter will be installed. When the potential for a cross contamination exists, an approved back flow prevention device must be installed and test submitted prior to the meter installation.
